ORDER:

In the G.O. 1st read above, orders were issued for sanction of Financial Assistance to Christian Minority Law Graduates to undergo Training in Administration of Justice on par with SC,BC,ST Law Graduates.

2. The Vice Chairman & Managing Director, A.P. State Minorities Finance Corporation has requested the Government to extend the scheme to Minorities Law Graduates on par with Christian Minorities with similar guidelines vide reference 2rd read above.

3. Government after careful examination of the proposal of the Vice Chairman & Managing Director, A.P. State Minorities Finance Corporation hereby issue the following orders to extend the benefits to Minority Law Graduates on par with Christian Minority Law Graduates:

- a) Two seats shall be allotted to each District. In total 26 Minority Law Graduates shall be trained every year.
- b) Every Minority Law Graduate shall be paid a stipend of Rs.1,000/- per month uniformly for all 3 years.
- c) Every Minority Law Graduate shall be paid an amount of Rs.6,000/- towards purchase of Books and Furniture as one time grant in the 1st year.
- d) An amount of Rs.2,000/- per annum shall be sanctioned to the candidate under training for Administration of Justice, for attending seminars, workshops, symposiums etc., that enhances advocacy skills of the candidate.
- e) Every Minority Law Graduate shall be sanctioned Enrollment Fee of Rs.585/- and wherein the Enrollment Fee is enhanced the same shall be reimbursed to them.
- f) Income limit for eligibility for admission of candidates for undergoing Training in Administration of Justice shall be in the pattern of Government of India in respect of Post Matric Scholarships for students in professional and post-graduate courses.
- g) The District Collectors are authorized to call for applications to interview the candidates and select them for training at the rate of Two Minority Law Graduates for each District. If two or less applications are received, the candidates may be selected without any interview. If the applications are more than two, they may be selected through interview. In the event of interview, the District Collector may constitute a District Level Committee under his/her Chairmanship with District and Session Judge and Joint Collector as Members and District Minorities Welfare Officer as Member Convener.

- h) The selected candidates shall be attached to the Law Officers within the District (i.e. G.P., P.P. etc., of District Courts, Mobile Courts, Sessions Courts and also at the courts at the District Level/erstwhile Taluk level etc.,) wherever there are Law Officers.
- i) From the Minority Law Graduates who are applying for the Scheme shall be submitted the proof of record viz. School records (SSC Transfer Certificate), Revenue Records (Caste Certificate & Income Certificate) and necessary Educational Certificates.
- j) Enrollment / Registration with the Bar Council of India/State Bar Council of Andhra Pradesh shall be insisted.
4. The expenditure sanctioned in para (3) above shall be met from the available budget provision and debited to the following Head of Account:

"2225-80-800-GH(11)-SH(05) - Studies on Socio Economic conditions and Programmes of Minorities".

5. The Vice Chairman & Managing Director, A.P. State Minorities Finance Corporation shall take necessary action accordingly.
